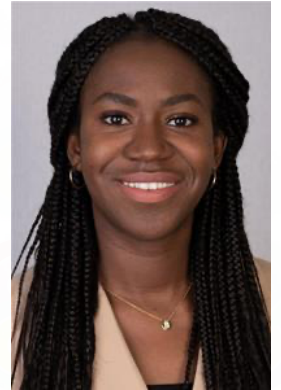


# What is the New Council Homes Programme? with Cllr Promise Knight

Cabinet Member for Housing, Homelessness and Renters Security



*Dear resident,*

I'm Councillor Promise Knight, Brent's cabinet member for housing, homelessness and renters security.

We have a chronic housing shortage here in Brent, as there is across London, and the people who really suffer because of this are larger families in Brent, who are very often living in unaffordable and overcrowded homes, or in temporary accommodation for many years. There are currently over 1,400 households in temporary accommodation in Brent and although this has been reducing year on year through our efforts, this is still too many families without a permanent home to call their own.

Currently the average wait for a three-bed home here in Brent is 14 years. We are determined to do something about this. In our manifesto we committed to delivering at least 1,000 new council homes ourselves and over 5,000 affordable homes with partners. We'll concentrate on bringing more accessible and family-sized homes forward, as fast as we can.

This is part of a much bigger picture. We are also investing in our relationships with private developers and our housing association partners, to make sure that we really increase the amount of genuinely affordable housing for families in Brent. The overall aim is to see an average of 1,000 new affordable homes built across Brent, every year for the next five years.

We do not have a huge amount of land to build on here in Brent, which is why we need to look at every opportunity to make the most of what we have. So that might mean better use of smaller parcels of land and looking at smaller developments to determine if they can be expanded.

I do appreciate that building in this way may result in building very close to existing homes and that this can be hugely disruptive. This makes it even more important that we listen to what current residents say, and that you are able to have your say when schemes come forward.

I hope my message and the information on our newsletter and website is helpful.

There are plenty of ways to contact us. We really do want to hear what you think and would welcome your feedback.

# Our vision for Yates Court

FBM Architects in collaboration with Brent Borough Council propose the demolition of the existing garages and the construction of four high quality courtyard-type houses with associated garden and amenity space.

The proposals include one 1-bedroom house, two 3-bedroom houses and one 4-bedroom house. The site is accessed via Willesden Lane and will boast a large, shared courtyard area to integrate new and existing buildings, increase parking provision and provide a space for refuse collection and cycle storage. A large, shared garden is also to be provided to the east of the site. The garden will be gated and only residents will be able to gain access.

The layout and orientation of the houses has been designed in such a way that it will prevent any overlooking into and of the neighbouring properties. Features such as angled windows, adjusting primary aspects and window positioning helps to prevent this.

Alongside a large, shared garden, each house has at least 50 square metres of private patio garden space.



## Summary of proposed development

- Provision of four high quality courtyard-type houses.
- Large, shared courtyard area and shared garden, only accessible to residents.
- Private patio space for each house.
- Walking distance from Willesden Green and Kilburn tube stations.
- Renovation of the garages which are of poor architectural quality.

## Why is this development being proposed?

It is widely appreciated that there is a housing crisis in the UK and that we are not building enough new homes. This is especially true in London where private housing is beyond the incomes of many families. Here in Brent we are proactively building new homes for our residents to help alleviate the shortage of homes.

The Mayor of London's New London Plan sets the ten-year targets for building new homes

for each one of London's Councils. Here in the London borough of Brent, the 10-year housing target is 29,150 homes to be built by 2028. This means we have to build 2,915 houses every year.

Therefore Brent Council needs to look carefully at all available land that we own on our existing estates and identify pieces of land like this one at Yates Court to provide more much needed housing.



As you can see from this aerial photograph, the site where we are planning to build 4 homes located at Yates Court. It is on an existing estate and will help meet the family housing need in the London Borough of Brent. We hope that you will support our plans and welcome the new residents to your neighbourhood.
