### Proposed Garnet Road Secure Cycle Parking Unit

This document outlines our proposals for the introduction of a Secure Cycle Parking Unit on Garnet Road NW10. Please read the information in this document, then complete, and return the enclosed questionnaire - **postage is free**. Alternatively, this document is also available for completion online at <https://haveyoursay.brent.gov.uk>. Responses from within the consultation area only will be considered. The closing date for the return of the questionnaire is **Friday 13 March 2026**.

#### Why are we proposing this change?

Brent Council aims to improve facilities for cyclists in the borough and promote active and sustainable travel. In line with the vision set out in our Active Travel Implementation Plan 2024 - 2029, the Council is encouraging more residents to take up cycling, to enjoy the health benefits that this brings and to help reduce traffic congestion and improve air quality in the borough.

The Council has received requests from residents in the Roundwood ward to provide secure cycle parking in streets where they do not have access to private outdoor space. Bikes can block hallways and staircases in some properties, and those left on street can be a target for cycle theft.

Through its NCIL funded cycle parking programme, the Council propose to install secure cycle parking units in areas where there is a high demand from local residents for this facility.

#### What is being proposed?



We are proposing to introduce a secure cycle parking unit on Garnet Road as shown on the enclosed plan. The proposed secure cycle parking unit would be located opposite entrance to St. Mary's CE School from approximately 90m to the East of the junction of Garnet Road and Mayo Road. The secure cycle parking unit will take half a car parking space.

The secure cycle parking unit, which has the capacity to store six bicycles, will be rented to users for an annual fee.

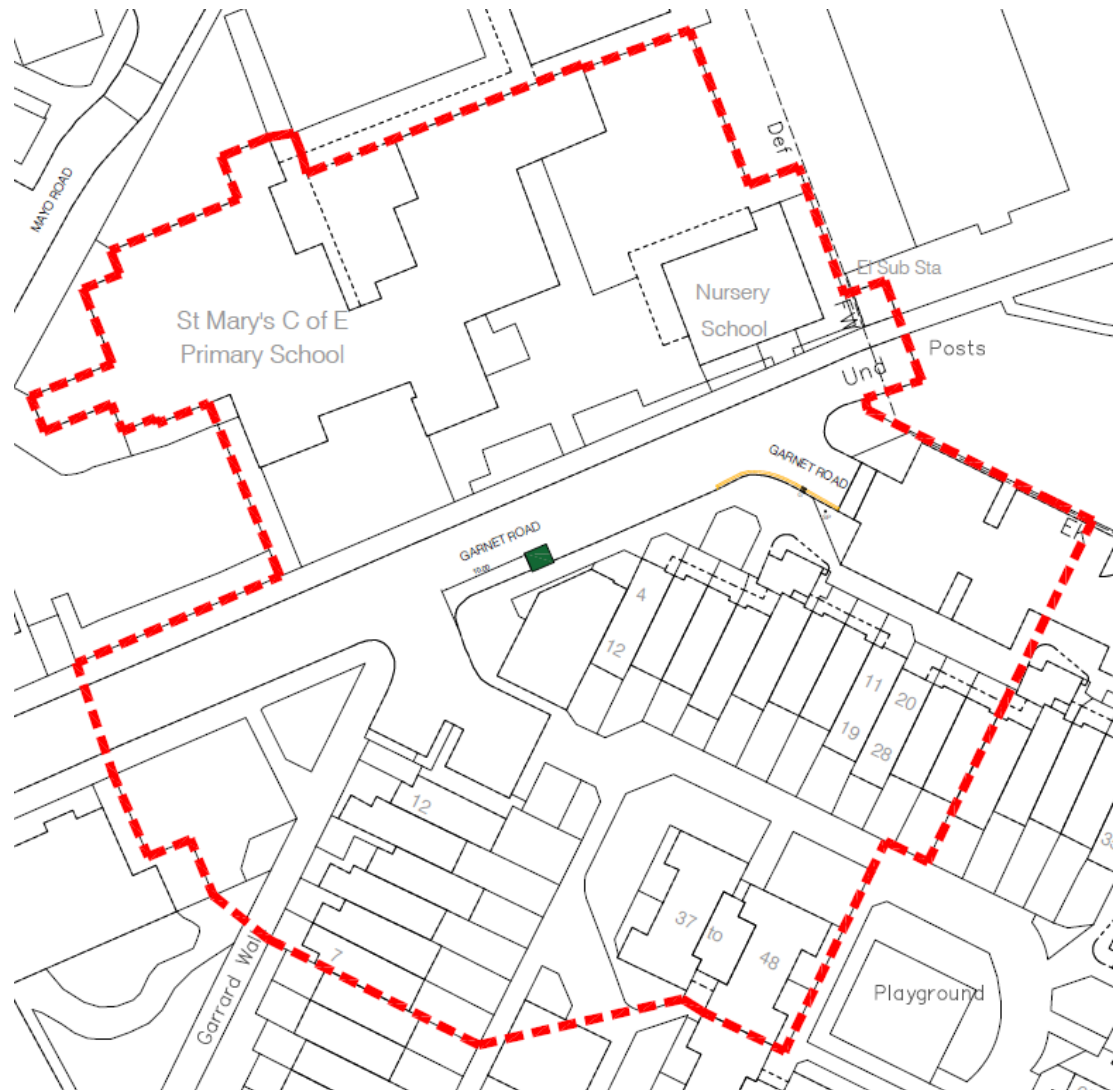
#### What will happen next?
